

## GROUP PURCHASING MASTER AGREEMENT

This **GROUP PURCHASING MASTER AGREEMENT** ("Agreement") is made and entered into as of this 1st day of January, 2026, (the "Effective Date") by and between EKF Diagnostics ("Supplier") and Blood Centers of America, Inc., a Delaware corporation ("BCA"). The Supplier and BCA are sometimes referred to herein individually as "Party" and collectively as the "Parties".

**WHEREAS**, BCA is a for-profit cooperative, representing and acting on behalf of the member institutions and affiliates as defined below and hereinafter referred to as "Member(s)"; and

**WHEREAS**, The Supplier and BCA desire to enter into an arrangement where the Supplier provides Products (defined below and/or in Exhibits), and BCA purchases Products on the terms and conditions outlined in this Agreement.

**NOW, THEREFORE**, the Parties hereto, intending to be legally bound, agree to the following:

### 1. DEFINITIONS

The following terms for the purpose of this Agreement shall have the following respective meanings:

- "Administrative Fee" shall mean a fee paid to BCA as a group purchasing organization pursuant to the Group Purchasing Organization Safe Harbor found at 42 C.F.R. §1001.952(j).
- "cGMP Requirements" means the FDA's current Good Manufacturing Practice requirements as promulgated under the FFDCAs at 21 CFR (Parts 210 and 211), and as further defined by FDA guidance documents, as such may be amended from time to time, applicable to the manufacturing, processing and packaging of the Products.
- "Confidential Information" is fully defined in Paragraph 9.5 of this Agreement.
- "Effective Date" means the date written in the preamble of this Agreement on which all terms and conditions herein commence.
- "FDA" shall mean the United States Food and Drug Administration, or any such successor agency of the United States Federal government.
- "Government or Regulatory Authority" means any United States federal, state, or local government, governmental instrumentality or governmental or other regulatory or administrative authority, agency, department, board or court, tribunal or judicial, administrative or arbitration tribunal, and any foreign counterpart thereof.
- "Law" means any federal, state or local law, statute or ordinance, or any rule, regulation, or published guideline, or any statement having the effect of law, promulgated by any United States Governmental or Regulatory Authority.
- "New Technology" shall mean introduction to the market of novel products or revolutionary technology post execution of the Agreement that substantially improves operations, product quality, donor safety, patient safety, or otherwise changes the standard of care.
- "Participating Member" refers to those Members who have agreed to be bound by the provisions of this Agreement through execution of a Participation Agreement as set forth in Paragraph 2.3 of this Agreement.

- “Contract Group” means BCA, Participating Members, and Supplier, each an “Adherent “and together “Adherents”
- “Product” shall mean any of the products or services set forth in **Exhibit A** attached hereto and made a part of the Agreement.

## 2. **PARTICIPATING MEMBERS**

- Member Institutions and Affiliates. **Exhibit B** lists the organizations eligible to participate in and benefit from this Agreement as of the Effective Date by virtue of their membership in or affiliation with BCA. Changes to such eligibility will be communicated in writing by BCA to the Supplier with a minimum of 30 days’ notice.
- New Members. Pending appropriate notification as set forth above, new Members are eligible to participate in this Agreement to the extent that they are not bound by the terms of an existing agreement.
- Member Agreements. Members will indicate their participation under this Agreement by executing a Participation Agreement (blank copy included as **Exhibit C**). Before signing the Participation Agreement, the Participating Member will ensure signing does not conflict with any other current contractual obligations. Upon execution, the Participating Member will be bound to the terms of this Agreement. Any obligation or benefit under this Agreement will endure for the term of the Agreement regardless of membership or affiliate status with BCA. Supplier will not negotiate directly outside the terms of this Agreement with any BCA Member, or separate from BCA’s negotiations on behalf of Members, an agreement for the purchase of such Product. Any existing Supplier agreement with a current BCA member will be subject to the terms and conditions of this Agreement
- Other Agreements During the Term of this Agreement, Supplier and Participating Members will make no other agreements for Products covered hereunder.

## 3. **TERM AND TERMINATION**

- Term. This Agreement will remain in effect for three (3) years (“Initial Term”) commencing on January 1<sup>st</sup> 2026 (Effective Date. Any renewal shall be subject to the mutual written agreement of the Parties.
- New Technology. During the course of the existing Agreement, if a New Technology becomes available and the Parties determine that the New Technology provides substantially improved operational performance and/or improved donor or recipient safety to the Members, and the New Technology is available from the current Supplier, then the current Supplier will negotiate with BCA toward an acceptable agreement which provides BCA the ability to convert to the New Technology. However, in the event the New Technology is not offered by the current Supplier but is available from a third party, the current supplier will, within thirty (30) days, notify BCA if they are able to modify their existing technology to provide equal operations and/or safety improvements as the New Technology within six (6) months after the date the New Technology is commercially available. If the current supplier is not able to provide such improvements within the six (6) month timeframe, then Participating Member will have the right to terminate their obligation under the current Agreement, in part or in whole, with sixty (60) days written notice to the Supplier.
- Termination for Cause. In addition to all other available remedies, either Party may terminate this Agreement following the other Party’s breach of any material term or condition of the Agreement, provided the defaulting Party has received written notice specifying the nature of the default and

the corrective action required, and such default is not cured with a written corrective action plan within thirty (30) days following receipt of said notice of default.

- Effect of Termination. Upon termination, neither Party will have any further obligation under this terminated Agreement except for (i) obligations accruing prior to the date of termination, (ii) obligations or covenants specifically stated in the Agreement (such as in Paragraph 3.2), and (iii) obligations or covenants contained in the Agreement that by their nature are intended to extend beyond termination, including, without limitation, covenants relating to taxes, confidentiality, indemnification and remedies. If personal data is processed by the Supplier then please refer to section 7 of the Data Processing Addendum.

#### 4. PURCHASES

- Products. Supplier agrees to provide to Participating Members Products in the attached **Exhibit A** according to the conditions set herein and as described by purchase order issued by Participating Member. Supplier represents and warrants that the Products supplied to Participating Member under this Agreement shall conform to and perform in accordance with the Supplier's published specifications at the time of delivery. Supplier will not negotiate directly outside the terms of this Agreement with any BCA Member, or separate from BCA's negotiations on behalf of Members, an agreement for the purchase of such Product.
- Product Performance. Supplier agrees to track and trend product issues where products do not meet specifications at least 98% of the time for the aggregate BCA volume, as represented in 4.1 above. Supplier agrees to address trends where the product is not meeting performance expectations using established performance improvement tactics. A written corrective action plan with target dates identified and agreed upon by BCA will be implemented and reviewed regularly.
- Changes in Products. If a Product is discontinued, the regulatory status of a Product changes, or the Supplier ceases to market a Product, the Supplier will provide BCA with a minimum ninety (90) days advanced written notification.
- Order Placement. Participating Member will issue a purchase order by phone, fax or electronic submission directly to Supplier, and Supplier will acknowledge each order and reference the purchase order number on all confirmations, invoices, packages and packing slips. Shipment of any order, including standing order, will be made in accordance with terms, conditions and prices in effect, as stated herein or supplied hereafter, and shall be governed solely by the terms of the Agreement notwithstanding any conflicting or additional terms contained in any purchase order or other instrument. Neither the Supplier's failure to object to any such conflicting or additional terms, nor the referencing by the Supplier of a purchase order number in connection with a shipment, delivery or invoice will be deemed to constitute the Supplier's agreement to such conflicting or additional terms.
- Minimum Order. Except as per Supplier and BCA's mutual agreement and as otherwise set forth in **Exhibit A** hereto, Supplier shall have no minimum purchase order requirement applicable to any or all Participating Members provided that orders are placed in accordance with Supplier's standard unit of measure for the items purchased.
- Return of Goods. At the discretion of the Participating Member, when no fault or defect is found with the Products, Products may be returned to Supplier provided (i) packages are unopened, (ii) Products have at least four (4) months shelf-life remaining, (iii) Products have not been discontinued by Supplier, (iv) Participating Member notifies supplier, and receives receipt of notification by Supplier, that Product(s) will be returned, (v) Participating Member will accept credit

totaling seventy-five (75%) of the purchase price for the returned Products, and (v) Participating Member pays for cost of shipment. Handling of Products that are not acceptable is described in Paragraph 6.4 below.

## 5. PRICING AND PAYMENT

- Pricing. The prices of the Products are as stated in **Exhibit A** and will remain fixed for the Term.
- Adding New Products. Supplier agrees to inform BCA of new products that Supplier plans to introduce to the market as far in advance as possible before their market introduction. These updates may be provided during quarterly business reviews as outlined in Paragraph 7.2 of this Agreement. Pricing for any additional and/or new products to be added to **Exhibit A** will be negotiated at prices consistent with the prices of Products already covered by this Agreement.
- Invoices. The Supplier will send invoices to the address indicated on the purchase order within ninety (90) days of delivery. Disputed invoices will be resolved before payment is rendered.
- Payment Terms. Participating Members will pay all undisputed charges, in full, within forty-five (45) days following the date of the invoice. Payment will be made in U.S. Dollars to Supplier's remittance address set forth in the invoice or to such other place as Supplier may designate in writing. Prompt payment discount of 1% will be granted on all payments received in less than 10 days from invoice date. Participating Member shall pay Supplier a late payment charge of one and one-half percent (1-1/2%) per month, eighteen percent (18%) per year, (or the highest amount allowed by law, if lower) on all amounts past due.

## 6. TRANSPORTATION AND DELIVERY

- Packing. The Supplier will pack and ship the Products using good commercial practice to ensure that no damage results from weather or transportation. The Supplier will label shipments of fragile, perishable, electrical, chemical or otherwise hazardous equipment or material appropriately and in accordance with local, state and federal laws.
- Shipping. Under normal conditions, Supplier will use all reasonable efforts to ensure receipt of shipment by Participating Member within ten (10) working days after receipt of such member's order. The Supplier will promptly notify the Participating Member if an occasion ever arises where the Supplier will not expect to be able to deliver the Products within this timeframe.
- Freight terms. Supplier shall bear the cost of freight (FCA (Incoterms® 2010) Destination Participating Member) for all orders placed under this Agreement except for express or rush shipping arrangements requested by Participating Member. Product to be shipped Ex-Works (EXW). When a method of transportation more expensive than the norm is requested, such as airfreight, inside delivery, rush or multiple deliveries, the difference in cost will be added to the invoice and will be subject to the terms set forth above in Paragraph 5.4. No additional shipping or handling charges may be applied beyond the direct carrier costs incurred by the Supplier. BCA shall have the right to audit express or rush shipping charges upon request but not more than once annually.
- Product Acceptance. Participating Members shall have ten (10) business days from the date of delivery in which to inspect the Products and to accept or reject such Products. If any portion of the shipment's Products are found to be defective in material or workmanship, broken or damaged, or otherwise not in conformity with the requirements of this Agreement, the Participating Member shall have the right to return, at Supplier's cost, the damaged Products, at the Participating Member's option, for (i) full credit of purchase price or (ii) replacement of the damaged Products. Such unacceptable Products shall be deemed not to have been delivered until replaced by the Supplier with acceptable Products. Payment shall not constitute acceptance. Use of a portion of

the Products for the purpose of testing for conformity with specifications shall not constitute acceptance.

- Failure to Deliver. In the event a Supplier is unable to provide Products within ten (10) working days after the agreed delivery date, as outlined in Paragraph 6.2 of this Agreement, the Participating Member may purchase any substitute Products from another source, and Supplier shall reimburse Member for the difference between Member's actual F.O.B. destination acquisition cost for the Products and prices Member would have paid for Supplier's Products under this Agreement. In addition, upon the request of such Participating Member, Supplier will assist Member to source and attain an acceptable alternative for the Product(s) that Supplier cannot deliver according to the guaranteed delivery timeframe specified in Paragraph 6.2 of this Agreement.
- Delivery under Emergency Conditions. In the event of a natural disaster or industry-wide shortage of Products ("Emergency Condition"), Supplier shall use all efforts to fill orders, but shall not be liable for nonperformance or delays resulting from causes beyond its control. Such causes may be in the form of transportation issues, or Force Majeur as described in Paragraph 9.12. Supplier will notify BCA and each Participating Member of such Emergency Condition and its expected duration and take all reasonably necessary steps to recommence its performance under this Agreement. Further, Participating Member agrees that in such events Supplier, without liability to Participating Member or BCA, may allocate Products among all of its customers, and Supplier agrees that favor will not be granted to other customers' orders over those placed by Participating Members during the duration of the Emergency condition. In addition, Supplier will notify each Participating Member of the estimated quantity of Products available to that Member.

## 7. SUPPORT AND RESPONSIBILITIES

- Supplier Representative. Supplier will provide representatives to call upon Participating Members on a periodic basis mutually agreed to by Supplier and each individual Participating Member. Supplier's representatives shall comply with any policies of BCA and Participating Members, and with all terms and conditions set forth herein.
- Quarterly Business Reviews. Supplier and BCA agree to hold quarterly business reviews at times and places mutually agreed upon, in person or by teleconference, for the purpose of reviewing past performance and for mutually improving future performance and communications. Each party shall be responsible for its own costs in attending these meetings and will assure that these meetings are attended by its experts in the areas to be covered.
- Training. Included in the price of the Products, Supplier will provide to each Participating Member, in-service, clinical training and/or training materials related to the Products or Product changes as required and/or requested by each Participating Member.
- Equipment Warranty. The warranty period for Equipment is two (2) years from date of installation. Participating Members must provide written notice to Supplier of a warranty claim within thirty (30) days of knowledge of the claim. The Supplier shall repair or replace defective Equipment. Modifications, alterations, or abuse and service by other than an authorized representative or failure by users to operate or store the equipment in accordance with procedures/manuals may void any warranty. Supplier will provide, in writing, a list of all preventive maintenance procedures, to include frequency of each that will occur during the warranty period.
- Maintenance and Repair. Following expiration of the Equipment warranty period for each respective piece of equipment, each Participating Member shall be responsible for the proper maintenance and repair of the Equipment, including purchasing the parts needed to maintain or repair the Equipment and for any service visits. Participating Member shall indemnify the Supplier

for any claims or losses caused by a failure by the Participating Member to properly maintain the Equipment or caused by any repairs not made by the Supplier.

- Metrics. Benchmarking metrics will be provided by the Supplier to BCA so that BCA may facilitate process efficiencies and improvements with each of the Participating Members. BCA will collaborate with the Supplier to develop metrics definitions, calculations and processes, ideally through an electronic data transfer to the BCA dashboard.
- BCA Responsibilities. BCA will support this Agreement and, thereby the Supplier, by (i) communicating to all BCA Members the terms and scope of this Agreement, (ii) assisting in the development and scheduling of educational and technical programs, (iii) facilitating the Supplier's access to Members and their key decision makers, (iv) circulating educational and promotional materials to Members as reasonably requested by the Supplier, (v) communicating data to Members regarding their level of participation and/or opportunities.
- Supplier Qualification. Supplier agrees to be responsive and support the efforts by BCA and Participating Members to perform Supplier/Vendor Qualification as set forth in individual quality manuals for the purposes of meeting regulatory requirements. BCA shall have the right to conduct any inspections or audits relating to the Supplier's performance under these general terms, including at the Supplier's premises.
- Supplier Cyber Security. Supplier, directly and through its third-party providers, shall undertake and perform commercially reasonable measures designed to ensure the security, confidentiality, and integrity of its data. Supplier agrees to be able to provide BCA with evidence of a third-party security assessment including without limitation, relevant technical and organizational security measures within the preceding 12 months.
- Disaster Preparedness and Business Continuity. Supplier agrees to be able to provide BCA with evidence of a business continuity plan. Supplier agrees to be able to provide BCA with evidence of testing of the business continuity plan within the previous 12 months. Should such testing of the plan create downtime for BCA or Participating Member then the Supplier shall notify the BCA and / or the Participating Member at least thirty (30) days prior to the execution of the testing,

## 8. **BCA ADMINISTRATIVE FEES**

- Sales Documentation. Supplier will provide BCA with quarterly reports of all Products purchased by each Participating Member during each calendar quarter of the term. Supplier shall provide BCA such reports no later than thirty (30) days after the last day of the applicable calendar quarter. Reports will include, without limitation, reporting period start and end dates, Participating Member name, city, state, and sales volume and spend per Product. Reports will be presented in a mutually agreeable electronic format.
- Fee Payment. Supplier will pay BCA an administrative fee equal to three percent (3%) of the net dollar volume of Products purchased by Participating Members through the Supplier during the term of this Agreement. Supplier will pay the fee to BCA annually, without demand or notice, within thirty (30) days of the end of each annual period during the term.

## 9. **GENERAL PROVISIONS**

- Assignment. This Agreement and all of the terms and provisions hereof shall be binding upon and inure to the benefit of the Contract Group and their respective successors and permitted assigns,

and neither this Agreement nor any of the rights, interests or obligations hereunder of the Contract Group may be assigned by any of the Adherents hereto without the prior written consent of the Parties, which consent shall not be unreasonably withheld or delayed. Consent by either Party to such assignment or delegation in one instance will not constitute consent by the Party to any other assignment or delegation. Notwithstanding the above, Supplier, BCA, or Participating Member may assign or delegate in whole or in parts its rights and obligations hereunder to (i) any entity which is an affiliate of such party; (ii) a successor entity of such party as part of an internal reorganization which results in party being organized in a different legal entity or corporate form, whether through conversion, merger, or otherwise, and (iii) an entity that acquires all or substantially all of such party's assets or business. Any assignment made in contravention of the terms of this paragraph shall be void ab initio.

- Independent Contractors. The Contract Group acknowledge, agree and declare that the relationship hereby established between them is solely that of provider and recipient and that each Adherent hereto is an independent contractor with respect to the others. Nothing contained in this Agreement shall be construed as creating a partnership, joint venture or agency relationship between the Adherents or, except as otherwise expressly provided in this Agreement, as granting any Adherent the authority to bind or contract any obligation in the name of or on account of another Adherent or to make any statements, representations, warranties or commitments on behalf of the other Adherents. All persons employed by an Adherent shall be employees of such Adherent and not of the other Adherents and all costs and obligations incurred by reason of any such employment shall be for the account and expense of such Adherent.
- Trade Names and Trademarks. BCA, the Supplier and the Participating Members will not issue any press release or make any announcement regarding this Agreement nor use the name or any trademark or service mark of another party or any of its affiliates without the prior written consent of the other party, with exception those communications among Parties for the sole purpose of meeting the obligations set forth herein.
- Third-Party Beneficiaries. The provisions of this Agreement are for the sole benefit of the Parties and their successors and permitted assigns, and they shall not be construed as conferring any rights to any other persons except as otherwise provided in this Agreement.
- Confidentiality. Except as otherwise set forth in or necessary to carry out the provisions of this Agreement, any information or data (including but not limited to, any technical information, experience or data) regarding any Adherent's plans, programs, plants, processes, technical materials, Product, production requirements, standard specifications, costs, equipment, operations, procedures, instructions, or customers (all of which is herein referred to as "Confidential Information") is the sole property of the respective Adherent. Each Adherent shall treat the other Adherent's Confidential Information in the same protective manner that it treats its own Confidential Information. Adherents shall not use, except for the purpose of carrying out this Agreement, or disclose to others or permit their employees or agents to use, during the term of this Agreement and for a period of five (5) years from the date of termination of this Agreement, Confidential Information which has heretofore come or hereafter may come within the knowledge of, or which has been or may hereafter be acquired or developed by the respective party, its employees or agents, in the performance of any services hereunder. This provision shall not prevent any Adherent from using or disclosing to other information: (i) which is known to the receiving Adherent at the time it is obtained from the disclosing Adherent, which knowledge can be established by competent evidence; or (ii) which is, or through no fault of the receiving Adherent becomes, lawfully available to the public; or (iii) which lawfully becomes available to the receiving Adherent from a source other than the disclosing Adherent; or (iv) which the receiving Party is required by applicable Law, a court having jurisdiction, or Government or Regulatory Authority to disclose (provided that reasonable prior notice and an opportunity to limit such disclosure is provided to the other Adherent).

- Compliance with Law. Each Party shall comply with, and shall not be in material violation of, all valid, applicable Laws that materially affect such Party's performance of its obligations under this Agreement.
- Notice to Employees. Whereby one or more Participating Members have government contracts, the complete text of 29 CFR part 471 Appendix A to subpart A is hereby incorporated into this Agreement. For purposes of this regulation, the Supplier is considered a subcontractor and agrees to post notices, to the degree required by law, informing employees of their rights under the National Labor Relations Act (NLRA).
- Indemnification. Supplier, BCA, and the Participating Members (in each case and when applicable, an "Indemnifying Party") agrees to indemnify and hold harmless the other Adherent(s) and their respective employees against any and all third-party claims, losses, damages and liabilities, including reasonable attorney's fees, arising out of (i) the Indemnifying Party's failure to manufacture, deliver, handle, store or use Products according to written specifications and instructions; or (ii) any breach of agreements, representations, warranties or covenants contained in this Agreement by such Indemnifying Party. If personal data is processed by the Supplier then please refer to section 19 of the Data Processing Addendum.
- No Waiver. The failure of either Party to terminate this Agreement by reason of the breach of any of its provisions by the other Party shall not be construed as a waiver of the rights or remedies available for any subsequent breach of the terms and provisions of this Agreement.
- Limitation of Liability. Neither Party shall be liable to the other for special, indirect, incidental or consequential damages. In any case, liability under the Agreement is limited to the total value of shipments made. If personal data is processed by the Supplier then please refer to section 20 of the Data Processing Addendum.
- Insurance. The Supplier will maintain product liability and general liability insurance against any insurable claims that are reasonably likely to arise regarding Products purchased from the Supplier. Supplier will maintain cyber liability insurance, providing coverage for claims and losses with respect to network or data risks (such as data breaches, release of confidential information, unauthorized access/use of data, and identity theft) with minimum aggregate limits of not less than \$5 million
- Force Majeure. Failure of any Adherent to perform its obligations under this Agreement shall not subject such Adherent to any liability to another Adherent if such failure is caused by any cause beyond the reasonable control of such nonperforming Adherent, including, but not limited to, acts of God, fire, explosion, flood, drought, war, riot, sabotage, terrorism, embargo or national health emergency.
- Dispute Resolution. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules. The resolution of the arbitrator(s) shall be binding on the Parties and either Party may enter any judgment or award rendered by the arbitrator(s) in any court having jurisdiction thereof. The place of arbitration shall be Delaware.
- Governing Law. This Agreement, and all rights and obligations set forth herein, shall be governed by and construed according to the laws of the State of Delaware without regard to the provisions thereof concerning conflict of laws.
- Notices. Any notice or request expressly provided for or permitted under this Agreement shall be in writing and shall be deemed sufficiently given upon receipt when hand delivered or sent by nationally-recognized overnight delivery service at the address set forth below. Either Party, by written notice to the other, may change its address for receiving such notices.

10. **ENTIRE AGREEMENT**

- Entire Agreement. This Agreement, together with all exhibits and schedules attached hereto and referenced herein, constitutes the complete and exclusive statement of the agreement between the parties with respect to the subject matter hereof and shall supersede any other agreements or prior negotiations between the Supplier and BCA for the Products, including any present purchase arrangements/agreements by and between Participating Member and the Supplier. The terms of any purchase order, invoice, or similar document used to implement this agreement shall be subject to and shall not modify this Agreement.
- Amendment. To be effective, amendments to this Agreement shall be in writing, attached to or made a part of this Agreement, and executed by an authorized representative of BCA and the Supplier.
- Counterparts. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original and all of which taken together shall be deemed to constitute one and the same instrument. An executed signature page of this Agreement delivered by email transmission shall be as effective as an original executed signature page.
- Severability. If any provision of this Agreement is held to be invalid, illegal or unenforceable, in any respect then to the fullest extent permitted by applicable Law and if the rights or obligations of any Party will not be materially and adversely affected: (i) such provision will be given no effect by the Parties and shall not form part of this Agreement, (ii) all other provisions of this Agreement shall remain in full force and effect; and, (iii) the Parties will use their best efforts to negotiate a provision in replacement of the provision held invalid, illegal, or unenforceable that is consistent with applicable Law and achieve, as nearly as possible, the original intention of the Parties. 
